MESSAGE FROM OUR CHAIRMAN



In assuming office as Chairman at the 23rd Annual Leadership 100 Conference in February, I joined in the celebration of the 30th Anniversary of the Archbishop Iakovos Leadership 100 Endowment Fund, Inc., an organization that has truly become one of the pre-eminent Greek Orthodox charitable organizations in America, with membership and outreach around the world. It was indeed a blessing and privilege to hear the special message from His All Holiness Ecumenical Patriarch Bartholomew marking our anniversary and acknowledging the inspirational and tireless spiritual leadership of His Eminence Archbishop Demetrios over the 15 years since his Enthronement. I feel indebted to the leadership both in our Church and in Leadership 100, especially that of my predecessor, Charles H. Cotros, who led us to an impressive increase in membership, now 935, and a record distribution in grants, now exceeding \$38 million since our founding. I am also grateful to the many other illustrious Chairmen who have served before me, some of them the original founders called upon by Archbishop Iakovos of Blessed Memory to establish such a unique charitable endowment fund. Over this period, Leadership 100 has become an exceptionally well-

organized entity and continues today with extraordinary members from amongst the Greek American Community across the nation and with an exceptional staff led by Paulette Poulos, our gifted and much admired Executive Director.

As I see it, my role will be to continue in that tradition with the foremost priority to increase membership to 1,000 members from across the nation and across the generations. We are witnessing a generational transition with my election and that of my fellow Officers and with the growth of Leadership 100 Partners, now at 118. The same transition is occurring in many other institutions as well. Like those institutions we too celebrate the "Greatest Generation" of our Founders. With this emphasis on growth, those of us who have been privileged to be selected to carry on these traditions will be able to fulfill the even greater responsibility to be true to our very purpose and increase our grants in support of the National Ministries of the Greek Orthodox Archdiocese of America, advancing Orthodoxy and Hellenism.

Leadership 100 has also achieved high value and credibility with an excellent reputation through viable programs and events, including our Leadership 100 Annual Conferences, which have attracted the foremost leaders in our nation as members, speakers and participants who support our traditions and values. We must continue to devote energy and creativity in this area as a proven means to get out the message of who we are, what we contribute to our Church and to our Community and how we meet the many challenges in our society.

If we have learned anything from recent events in our nation and world, it is the importance of leadership that promotes responsibility, accountability and

transparency. With renewed purpose, Leadership 100 can be the harbinger of new directions in responsible and innovative philanthropy. We can move forward with confidence both in our past and in our future over the next two years if we work together.

George S. Tsandikos of New York, New York was inaugurated as the Chairman of Leadership 100 on February 15, 2014 at the Grand Gala of the 23rd Annual Leadership 100 Conference at The Ritz-Carlton, Naples in Naples, Florida. At 53, he is the youngest to serve in that post. He served as Vice Chairman for the past two years under Charles H. NEW CHAIRMAN MAKES APPOINTMENTS

In one of his first actions, he reappointed Peter A. Vlachos as Chair of the Investment Committee, John

GRANTS, ASSETS AND MEMBERSHIPS INCREASE


The Executive Committee convening at the 23rd Annual Leadership 100 Conference at The Ritz-Carlton, Naples, Naples, Florida approved \$2,453,833.50 in new grants and prior commitments for 2014, based on the recommendations of the Grant Committee, Chaired by John Sitilides. This brought the total of grants distributed by Leadership 100 since its inception to \$38,054,512. In addition, Peter Vlachos, Chairman of the Investment Committee, reported to the Executive Committee, Board of Trustees and General Assembly that in the year ended December 31, 2013 the Leadership 100 Endowment Fund rose 11.29% to \$82,717,395 from previous year-end value of \$75,448,411, while Paulette Poulos, Executive Director, reported to all three bodies that membership had increased to 935.

The new grants included for the Greek Orthodox Archdiocese of America: Department of Youth and Young Adult Ministries Camping Ministries, \$270,000; Office of Inter-Orthodox, Ecumenical and Interfaith Relations, \$150,000; The Center for Family Care, \$95,000 for Renewal of Family Ministry and \$20,360 for Seminarian and Clergy Couple Care; Department of Religious Education, \$80,000; Department of Administration Ministry Updates, \$57,042.50; and Orthodox Christian Prison Ministry, \$54,310. New grants for the Metropolises included Metropolis of Atlanta Family Life Ministry, \$100,000. Other new grants included Fordham University Orthodox Christian Studies Center, \$33,000; The Ecumenical Patriarchate Youth and Young Adult Conference, \$30,000; and St. Photios National Shrine,

\$8,100. Finally, prior grant commitments included Hellenic College/Holy Cross School of Theology Scholarship Program \$1,000,000 and Office of Vocation and Ministry, \$30,800; Greek Orthodox Archdiocese Strategic Plan Project, \$125,000, Office of Inter-Orthodox, Ecumenical and Interfaith Relations, \$90,000, Center for Family Care Men's Ministry Group, \$13,750, and Department of Marriage and Family, \$60,000; Metropolis of Boston Emerging Leaders Ministry, \$100,000; International Orthodox Christian Charities (IOCC) \$96,071; The Ecumenical Patriarchate Pastoral Health Care Conference, \$35,000; and Retired Clergy in Need, \$5,400.

NEW YORK PRIEST TO JOIN IOCC FRONTLINERS

Rev. Fr. Nikolas Karloutsos of Archangel Michael Church in Port Washington, New York was amongst the clergy who will join International Orthodox Christian Charities (IOCC) Frontliners for training at an event and meeting in Chicago from May 26 – 31, 2014, because of his exemplary pastoral and counseling skills and experience. Invitations have gone out to the existing 80 members of the Frontline and another 30 to join our group.

IOCC Frontliners consist of Orthodox clergy and laity, professionally trained and experienced in disaster response who have responded to man-made and natural disasters over the last several years. The program was supported with a Leadership 100 grant of \$178,941 over 2013 and 2014 for the Orthodox Community Action Network (CAN) for purposes of expanding its Orthodox Emergency Response Network

(ERN), which includes training programs for IOCC Frontliners. Local Orthodox Hierarchs will be invited to a dinner during the Chicago event hosted by His Eminence Archbishop Nicolae of the Romanian Archdiocese and the program's liaison to the Episcopal Assembly. Previous training took place in Denver in August of 2013.

Acute disasters – beginning with the events of September 11 and later

with Hurricane Katrina – led to the establishment of the IOCC Emergency Response Network (ERN). Typical deployments of the IOCC Frontliners are only a few days and entail provision of spiritual and emotional care, needs assessment, and logistics coordination. In 2013 Frontliners responded to the wildfires in Yarnell, AZ, the tornadoes in the Oklahoma City area and the floods in Colorado.



LEADERSHIP 100 CELEBRATES 30TH ANNIVERSARY AT CONFERENCE

The Archbishop Iakovos Leadership 100 Endowment Fund marked its 30th Anniversary at its 23rd Annual Conference, February 13-16, 2014 at The Ritz-Carlton, Naples in Naples, Florida. Some 400 members and their guests attended, according to Charles H. Cotros, the outgoing Chairman, who passed the torch of his office to George S. Tsandikos, Vice Chairman, at the Grand Gala on Saturday, February 15. The event featured a special message from His All Holiness Ecumenical Patriarch Bartholomew, who commended Leadership 100 for its 30 years of service to the Church and acknowledged His Eminence Archbishop Demetrios for his 15 years of service as Archbishop of America. The Archbishop was presented with a crystal encased

replica of the design for St. Nicholas Church, which is to be built overlooking the September 11 memorial in Lower Manhattan.

The Conference highlighted the future of the Church and philanthropy in America and the world with the presentation of the *Archbishop Iakovos Leadership 100 Award for Excellence* to the Stavros Niarchos Foundation, accepted by Vasili Tsamis, Chief Operating Officer, for worldwide innovative philanthropy; to the Seleni Institute, accepted by Nitzia Logothetis, Founder and Executive Chairwoman, for programs addressing women's health; and to Greek Orthodox Telecommunications (GOTelecom), accepted by Nicholas J. Furriss, Senior

Producer/Director, for the 26-program series, "Discovering Orthodox Christianity," funded with a Leadership 100 grant. The Conference also included a Personal Dialogue, "A Vision for the Future", with His Eminence Archbishop Demetrios, conducted by Charles H. Cotros; a Business Forum, "A Vision for the Future of Business", moderated by George S. Tsandikos, featuring George D. Behrakis, Chairman Emeritus of Leadership 100, John Catsimatidis, member of the Executive Committee and Board of Trustees of Leadership 100, and C. Dean Metropoulos, a long-time member of Leadership 100 and the newly-elected President of Faith: An Endowment for Orthodoxy & Hellenism, all leading businessmen and philanthropists.

NIARCHOS FOUNDATION BRINGS PHILANTHROPY HOME

In a wide-ranging address at the Hellenism Forum, Thursday, February 13, 2014, Vasili Tsamis, Chief Operating Officer and Co-Chief Investment Officer of the Stavros Niarchos Foundation, reminded his audience of the Greek roots of the concept of philanthropy. He described how the Foundation, in carrying out the legacy of Stavros Niarchos, strove to create a new model true to that concept in its philanthropic activities in Greece and around the world. The Niarchos Foundation was presented with the Archbishop Iakovos Leadership 100 Award for Excellence for its contributions.

After an introduction by Argyris Vassiliou, newly installed Vice Chairman of Leadership 100, who referred to the Foundation as one of the world's most successful and innovative non-profit organizations, Tsamis began his talk by stating that "philanthropia" meant far more than love of humanity for the ancient Greeks. Rather it referred to a life of perfect harmony on earth, a way of mindfulness together with good works that was the very essence of civilization and informed citizenship. Distinguishing philanthropy from charity, he said the latter "relieves pain deriving from social problems", whereas the former attempts to address problems at their root causes. He said the Niarchos Foundation was true to the legacy of its founder, Stavros Niarchos, who built one of the world's most successful "shipping empires" and "financial kingdoms" while giving back to the world at large what the world had given to him as opportunity, following his wishes to devote funding to Greece and Hellenism, education, social welfare, health and medicine, and arts and

culture all over the world, with the only limitation that 50 % of grants go to Greece. Since the year of the inception of the Foundation's activities that has translated into the distribution of 2,500 grants of \$1.5 billion in 100 countries.

With 55 partners in three offices around the world, the Niarchos Foundation follows a rigorous selection process in choosing grantees, insisting on a clearly expressed purpose, an identifiable cause, a master navigational plan, a stated timeline, and trustworthy management teams in place, all for the overriding goal of creating "a brighter and better tomorrow that can be shared with a healthy, prospering and proud state of affairs. He focused on the largest grant to date in 2011 in Greece, \$800 million to build the Stavros Niarchos Foundation Cultural Center that will include a 42-acre park and a home for both the National Library of Greece and the Greek National Opera, and that will be completed in 2016. He said the Foundation believed in the national importance of the project to Greece's future even more so under the current economic conditions, providing "a testament and commitment to the country's future and to its youth at a critical historical juncture." He said the project is also an engine of economic stimulus with an estimated short and long-term economic impact of \$1.3 billion. It would also provide a major cultural attraction and offer a broad range of programs in education, arts and culture, scholarship and entertainment. Furthermore, he predicted that it would become a case study and world class example of a new way of doing philanthropy

through a privately sourced and full-funded civic minded cultural development with future government support in delivering private and public benefits and interests.

Alluding directly to the economic crisis with a debt of \$325 billion, 30% unemployment and 60% youth unemployment, he said no philanthropic project, no matter how large and significant, could fully address such social and economic problems, but, citing a Chinese proverb, he said "a journey of a thousand miles starts with a small step." Even in the United States he said, where philanthropy and non-profit institutions represent 5 1/2 % of GDP with 85% of taxpayers donating and 30% volunteering, this compares to a national debt of \$16.5 trillion and GDP of \$12.5 trillion. Private philanthropy, he said, can never replace the state.

However, he emphasized that the Niarchos Foundation and all philanthropies must continue to strive to address these social and economic problems if they are true to their purpose. In this regard, the Foundation dedicated an additional \$135 million in relief efforts to ease the effects of the economic crisis in Greece, supporting organizations that the state could no longer support and which had had been diminished in size and significance in their outreach efforts, focusing on the most vulnerable, especially unemployed youth who were in danger of becoming a lost generation, becoming frightened and desperate and radicalized.

Tsamis noted that these problems of social and economic disarray were truly global and innovative ways must be found to address them. He appealed to his audience to continue God's work with deep compassion singly or jointly but preferably all together, congratulating Leadership 100 in carrying out the vision of its founder, Archbishop Iakovos for over 30 years of service, quoting John Lennon that "a dream you dream alone is only a dream but a dream you dream together is reality". Ending his talk he asked his listeners to be inspired by Abraham Lincoln's stirring words, "with malice toward none, with charity toward all, with firmness in the right as God gives us to see the right, let us strive on to finish the work we're in."

SELENI INSTITUTE MEETS CHALLENGES

Seleni Institute of New York, along with its co-founder and Executive Chairwoman, Nitzia Logothetis, was presented with the Archbishop Iakovos Leadership 100 Award for Excellence at the Saturday Forum on February 15, 2014, for its innovative work in creating a new modality for the treatment of women and their families. Founded in 2011 by Logothetis with her husband, George M. Logothetis, Chairman and CEO of the Libra Group, the Institute was named for Selene, the Greek goddess of the moon and Eleni, the heroic main character in the book of that name by Nicholas Gage, combining the concepts of emotion and bravery, according to Logothetis.

Logothetis, a trained psychotherapist with a professional background that ranges from work in Latin America, the UK and the

USA, spoke of the challenges women face in achieving pregnancy and delivering and raising children. These include accompanying high incidences of infertility, post-partum depression, miscarriage, still births and suicides, along with the underfunding of mental health compared to that of physical diseases. She said the role of Seleni was to destigmatize this “suffering shrouded in silence”, emphasizing that her research and experience have shown that children whose mothers do well, do well themselves and children whose mothers do poorly, do poorly. She went on to describe the three dimensions of Seleni's outreach. The first dimension is the Seleni Institute's clinic that treats 300 women and their families a week with psychiatry, psychotherapy, parental, sleep and lactation support, as well as a variety of

services such as acupuncture. Second is an extensive online presence that offers evidence-based, reasoned and practical wisdom based on modern science and empathy. Third are grants to researches in women's mental health from both national and international universities.

In conclusion, she paid tribute to her husband for his personal and professional support and said that Seleni offered women “a shoulder, a comfort, a resource, a community and empathy and healing”, lifting the burden that society places on women and their families, noting that 90% financial support is offered to those in need.

Prior to her address and after an introduction by Connie Cotros, wife of Charles Cotros, outgoing Leadership 100 Chairman, Andrew Stephanopoulos, Clinical Director of the Seleni Institute also addressed the Forum. He stated that the Institute was transforming mental health and wellness treatment describing the phenomenon of stigma as a defense that had to be overcome by connecting women at risk with a community of support. While also speaking of the treatment, online presence and research at Seleni Institute, Stephanopoulos spoke of needed change to the conversation on mental health issues through public information, sound media and the training of physicians, leading to the day when screening for depression and anxiety would be as commonplace as for physical disorders.

NICHOLAS J. FURRIS ON THE MINISTRY AND MESSAGE OF GREEK ORTHODOX TELECOMMUNICATIONS

Nicholas J. Furriss, the Emmy Award winning senior producer and director of Greek Orthodox Telecommunications (GOTelecom), addressed the Opening Forum on Thursday, February 13, 2014 and accepted the Archbishop Iakovos Leadership 100 Award for Excellence on behalf of GOTelecom, along with its Managing Director, Marissa Papageorge Costidis.

Introduced by John Sitalides, member of the Board of Trustees and Chairman of the Grant Committee, who described his “superb work in film making and production that has played an important role in advancing the Greek Orthodox Church across the USA and beyond its borders,” Furriss thanked Leadership 100 for decades of support through its grants of many of the most innovative programs GOTelecom has produced, describing the origins of the telecommunications ministry in 1988-89, with the support of His Eminence Archbishop Iakovos of Blessed Memory. He said that the support of His Eminence Archbishop Demetrios over the past 15 years has insured that GOTelecom continues to communicate the many ministries of the Archdiocese with programs that are aired nationally but always made available as resources to parishes, religious educators and the faithful. He also noted that Ecumenical Patriarch Bartholomew, then a Metropolitan, was also present at the beginnings of GOTelecom and has gone on to embrace video and the use of technology as a necessity for communicating the truth of Orthodoxy.

Furriss introduced a selection from his most recent project, wholly funded by Leadership 100, “Discovering Orthodox

Christianity”, twenty-two shows on a range of topics offering a basic understanding of Orthodox Christianity, the Greek Orthodox Church in America and its relevance in modern times, along with four Bible Studies offered by His Eminence Archbishop Demetrios of America. He said that the series was unique in the fact that many of the ministries and institutions of the Church that are supported by Leadership 100 are featured, providing a cross-promotion with multiple values in promoting those very ministries and institutions, the prime example being the use of Hellenic College/Holy Cross Greek Orthodox School of Theology, a major recipient of Leadership 100 grants, which was used instead of a traditional television studio set to produce the series. In addition, many other Leadership 100 grant recipients are featured, including the Department of Internet Ministries, the Department of Youth and Young Adult Ministries, the Department of Religious Education, the Center for Family Care, and the National Forum of Greek Orthodox Church Musicians.

He said that the Leadership 100 grant created both a challenge and an obligation to make this series of the highest quality with precise messaging and content and thoughtful promotion with availability across a number of traditional and non-traditional mediums allowing accessibility. This required, he stated, thorough pre-production, a logistical tour-de-force of the production itself with comprehensive post-production, encoding to formats to be used in distribution and marketing the series both to Orthodox and non-Orthodox alike. He said this encompassed utilizing

not only the communication channels and You Tube Channel of the Archdiocese but social media such as Facebook and Twitter, traditional DVD distribution, the use of the world-wide web, as well as new media outlets such as Wherever TV, an over the top internet television platform focused on delivering linear television programming to SmartTV’s, digital media receivers such as GoogleTV, AppleTV, Roku, iPhones, and iPads using the internet.

Furriss then spoke directly to the many Leadership 100 members who are in business of the Return on Investment or ROI of the Leadership 100 grants from two perspectives: the traditional advertising ‘cost per lead’ perspective, “which in itself is a bit unique since we are not selling an item per se but rather an intangible way of life through the grace of an institution,” and from another point of view - that of both an Orthodox Christian and an institutional Church.

From a ‘cost per lead’...or rather a better term in this context...a ‘cost of impression’ (be it transformative/spiritually nourishing or simply educational for both the Orthodox and non-Orthodox alike), he calculated an ROI of the grant at \$361,600 to date over just 3 1/2 months, exceeding the full grant of \$270,000. Over the course of time, he said, the viewership and impressions online alone will certainly continue to climb into the hundreds of thousands worldwide! It also is important to note, he said, that the material is evergreen in nature and can be used for many years to come! Furthermore, he cited approaches by television outlets to obtain rights to air programs, which he said would be granted in order to spread the message of Orthodoxy to an even broader audience.

Concluding that he is not comfortable with that type of ROI from the perspective of the Holy Orthodox Church and its mission of salvation universally, he asked, “If we have saved one soul, what is that worth? If we have assisted our religious educators to use these shows to inspire the youth and our leaders of tomorrow to a better understanding of their Faith, what is that worth? The reaction to the series has been outstanding! There is no measureable value..., they are simply priceless...and some things, money cannot buy! Thus, in my humble opinion, and I am sure in the opinions of many others, Leadership 100 and its impact on the Church and the lives of its faithful people is simply priceless!”

BUSINESS FORUM PROVIDES PERSPECTIVE

Three of the leading businessmen in America, all long-time members of Leadership 100, addressed the 23rd Annual Leadership 100 Conference on Friday, February 14, 2014, and gave their unique individual perspectives in a wide-ranging dialogue titled “A Vision for the Future of Business.”

Beginning with introductory remarks on the importance of their faith and values to their business success and personal lives, George D. Behrakis, John Catsimatidis, and C. Dean Metropoulos responded to questions moderated by George S. Tsandikos, the new Chairman of Leadership 100, who is Managing Director of Rockefeller & Company in New York City. They concluded the forum with a consensus on the future for Greek Americans seeking to balance spiritual growth with business success in a challenging time.

Behrakis, a Chairman Emeritus of Leadership 100 and a pioneer in the pharmaceutical field, as well as a renowned philanthropist in medicine and health, higher education and the arts, spoke of the advantage of being raised in a tight-knit Greek American Community in Lowell, Massachusetts, where the church inculcated values while he learned early about business and making a profit by working in his uncle’s restaurant. He spoke of the risks and benefits of going into business for himself after a successful career working at Johnson & Johnson. In response to questions about new opportunities in business, he spoke of new developments in pharmaceuticals, advances in medical technologies for diagnosis and treatment, as well as advances in nutritional science. He also addressed the importance of knowing how and when to promote products to the general public.

Catsimatidis, a member of the Leadership 100 Executive Committee and Board of Trustees, is the Chairman and CEO of the Red Apple Group, which

has holdings in oil refining, retail petroleum products, convenience stores, real estate, aviation, and supermarkets, with investments in both medical and industrial technology. He described his early success in expanding from one store to ten as due to developing trust and integrity with the people with whom one does business and that the key to success in his own business expansion was investment in real estate. Catsimatidis, who finished second in the primary race for the Republican nomination for Mayor of New York City in September of 2013, emphasized the unique opportunities in America as a land of opportunity and that successful business people had to set good examples for youth in working hard at what they do. He also addressed changes in the food business with respect to advances in health and nutrition.

C. Dean Metropoulos, who was recently elected President of Faith: An Endowment for Orthodoxy & Hellenism, is Chairman and CEO of Metropoulos & Company, a boutique

acquisition and management firm with offices in New York and Greenwich, Connecticut, which has acquired and repositioned more than 300 brands worldwide, with more than 78 acquisitions involving over \$48 billion in invested capital. He said that beyond hard work, businesses need vision and a clear mission in order to succeed and that in the many acquisitions he had undertaken it didn’t take long to determine whether or not there was

excitement and passion in management. When that is present, he said, it will release the creative energy of a workforce. He also said that research and development were becoming increasingly important with respect to consumer goods in offering alternative choices.

The Business Forum was designed by Leadership 100 Partners primarily to provide younger members of Leadership 100, Leadership 100 Partners and other young professionals with guidance in their careers. Younger members asked many of the questions, ranging from such specifics as how to market a brand product to consumers and how to deal with rules and regulations that encumber business development to how to balance a career with family life and church and how to successfully network to get started in a career.

All members of the forum agreed that while younger members beginning their careers had to be sure to exhibit perseverance and determination, those who have become successful should find more innovative ways of opening opportunities through institutionalizing networking within the Greek Community.

In a poignant conclusion, each of the participants spoke of overcoming difficulties in their careers. Metropoulos said that the energy and personality it takes come from beyond oneself as one learns to persevere through discouragement. Catsimatidis said he learned early to remain calm when things weren’t going one’s way; find out what one was doing wrong and fix it. Behrakis emphasized again the

importance of faith and family as support. They agreed that we live today in a more complex and challenging social environment with greater global competition but that the young Greek Americans they encounter possess the talent and energy that characterized previous generations with the added benefit of greater education in an America that remains the land of opportunity.

You assumed your duties as another successful conference concluded. This year also marks the 30th Anniversary of L100. How does all that make you feel?

The growth and success of Leadership 100 is remarkable. Since its inception, the organization has awarded grants totaling over \$38 million. Our investments now total \$82 million and we continue to grow. You hold a very important position in a huge company and you could help Orthodoxy and Hellenism by donating, as I'm sure you have done, some generous amounts of money to one or more causes of your choice and live happily ever after. And yet you chose to get involved, actually to become chairman of the L100. Why?

Because of the extraordinary people involved. From the dedicated staff led by the indefatigable Paulette Poulos, to the Founders, officers, board members and all members, we all share a love of our Church and Hellenism.

George S. Tsandikos from New York, was inaugurated Chairman of Leadership 100 at the concluding Grand Gala of the 23rd Annual Leadership 100 Conference in Naples, Florida. He served as Vice Chairman for the past two years under Charles H. Cotros of Memphis, Tennessee, whose term was completed as Chairman but who remains a member of the Executive Committee.

Tsandikos has been Managing Director of Rockefeller & Company in New York since 2003, having previously served as Vice President of J.P. Morgan Private Bank, also in New York, from 1989 to 2003. He has also worked as an Associate with Burns and Levinson, Counselors at Law, Boston, from 1987 to 1989. He holds an A.B. in economics from Brown University, Providence, Rhode Island, and a J.D., Cum Laude, from Boston College Law School, Newton Centre, Massachusetts. Tsandikos is a member of Holy Trinity Archdiocesan Cathedral of New York and an Archon of the Ecumenical Patriarchate.

In an interview with NEO magazine he highlighted his priorities as Chairman and his vision for the organization.

There has been talk that L100 doesn't do enough when it comes to helping Hellenic education and the national issues of Greece and Cyprus in the US. Given that L100 is an Endowment Fund, is that possible in the first place and to what extent?

The amounts contributed to Leadership 100 are inviolate – only the income and capital appreciation are available for grants. Then, of course, in accordance with our Regulations, the purpose of the organization is to seed and nurture the national ministries of our Church. I feel strongly that in so supporting these national ministries, the causes you mention – all very worthy and important – benefit. Still, we have tried to be helpful in a more direct way as well. For instance, many of our members came forward and responded directly to the appeal of His Eminence Archbishop Demetrios when he wrote to us and asked for our assistance for the crisis in Greece.

Despite the legal restrictions in getting L100 involved in causes other than helping the church, do you believe that as a forum it is strategically positioned to serve as breeding ground for ideas and initiatives that might expand beyond its stated purpose? I think the Hellenic Initiative, even the National Hellenic Society, are a

result of such a process.

I believe the Church is the breeding ground from which all begins. So far Leadership 100 has provided scholarships to seminarians at Holy Cross School of Theology totaling over \$15 million. Certainly over the years our clergy have played a key role in all ideas and initiatives that help promote Orthodoxy and Hellenism. So we need to be sure we continue to have qualified, good priests and we do not want the financial challenge of tuition to dissuade anyone. So, yes, we are such a breeding ground.

A message that you would like to extend to L100 members and the community at large?

I would like to thank the members for their commitment and encourage them to spread the word and help keep Leadership 100 growing.

After your tenure will be over in two years time, is there something in particular that you would like to have accomplished and be remembered by?

If we reach 1,000 members by the end of my tenure, I will be very pleased.

Founding Father Peter M. Dion

Peter M. Dion is along with Arthur Anton, Andrew Athens, Thomas Athens, George Chimples, Michael Jaharis and George Kokalis, a founding father of Leadership 100. Clearly moved and speaking to NEO magazine at the end of the conference, he recalled the inaugural meeting of Denver, CO in 1984 and how it managed to go beyond the initial, very optimistic, goal of 10 members to 18!

It's the 30th Anniversary of an organization which you were instrumental in putting together. What are your thoughts as another successful conference is about to conclude.

This is indeed the best conference I've ever been.

Now we have come to the next level and I think that before the end of the year we will have a thousand members and maybe more! I can tell you this conference is special because not only do we have people from all over the country, but we have young people. I am so proud to be a founding member of this organization and to be a Greek American. I came from the old country with no shoes and to me it means a lot to be part of this and to have helped start an organization like this.

Back then when you started it did you expect this growth?

Archbishop Iakovos did not believe we could get 10 Greeks to contribute \$100,000 each. But we insisted and we won by one vote (in deciding to form the Leadership). That evening in Denver my wife and my daughters became members. And of course, so did the rest of the founders. To make a long story short, when we left Denver we had 18 members! And they all paid the full amount of \$100,000! And for some time we had to pay for operating expenses from our pockets. So yes, I am very proud that the seeds we sowed then, have blossomed to this beautiful organization. And let me tell you something else: in our history as people, never before have 1000 Greeks come together, in unity, to do good for the Greeks! Everybody you see here, not only pay the membership fees, but they have to cover traveling expenses, accommodation, plus conference participation. (TURNING TO PAULETTE POULOS) I love this young lady; she is like my third daughter. Nobody knows better than me what she has done for this organization.

Nicholas J. Bouras

Nicholas J. Bouras, the revered businessman and philanthropist whose generosity to the Greek Orthodox Church and the Ecumenical Patriarchate was legendary, was mourned by hundreds of friends, family members and admirers at Holy Trinity Greek Orthodox Church, Westfield, New Jersey, on December 28, 2013. He had passed away at the age of 93 on December 22. He was noted for his long-time activity as Archon Depoutatos of the Ecumenical Patriarchate, Order of Saint Andrew, where he served as

National Vice Commander and from which he received its highest honor, the Patriarch Athenagoras Human Rights Award in 2006, as well as for his heroic service with the U.S. Army Air Corps during World War II. One of the first members to join Leadership 100, he was a member of the Board of Trustees since 1997 and was voted unanimously by the Board in 2010 as "Honorary Life-Time Member" and presented with the Archbishop Iakovos Leadership 100 Award for Excellence for his extraordinary service and philanthropy.

Bouras was born in Pontiac, Michigan, grew up in Chicago and graduated from the School of Commerce, Northwestern University. He spent some 20 years with United States Steel Corporation before beginning his own steel construction company with his wife, Anna K, Bouras, of Blessed Memory, in 1960. He had enlisted in the U.S. Army Air Corps in 1942 and flew 44 combat missions as lead bombardier and navigator, reaching the rank of Major. He was awarded the Distinguished Flying Cross, eight Air Medals and five Battle Stars.

Bouras Industries grew to consist of five operating companies with five manufacturing operations in New Jersey, Pennsylvania, South Carolina and Illinois, and became an industry leader in joist and deck production before being sold in 2007. He continued to operate Bouras Properties, LLC, the real estate arm of the company, from the same location.

Bouras was a founder and active member of Holy Trinity Church, where he served as President and Chairman of the building committee, an active member of the Archdiocesan Council, serving for 25 years, four years on its Executive Committee. He was also awarded an Honorary Doctorate by Hellenic College/Holy Cross School of Theology and was a recipient of the Ellis Island Medal of Honor.

GEORGE SAKELLARIS AT THE WHEEL WINS TOP YACHT RACES

George Sakellaris, a prominent member of Leadership 100 along with his wife, Caterina Papoulias-Sakellaris, who serves on the Board of Trustees, and their two children, Christina and Peter, has made his mark not only in business and philanthropy but also in the highly competitive field of yacht racing.

The President, CEO and Chairman of the Board of Ameresco, where he has been a pioneer in energy efficiency and renewable energy, racked up his most recent victory when his yacht *Shockwave* won the 2014 Caribbean 600 race, a real testament to his team building talent.

The Caribbean 600 is one of the most challenging ocean races in the world because there are 20 turning points and a dozen islands that need to be rounded. The 2014 race took 600 miles of team work on the part of *Shockwave's* crew to win it. As Sakellaris said at the finish: "At the end of the day, winning yacht races is all about the team performance more than anything else."

Most likely one of the most prominent Greek-Americans to be owner-skipper, Sakellaris is also unique in having always driven every mile of *Shockwave's* very challenging "around the buoy" racing. In his early ocean racing he left most of the rough and night driving to the professionals, but in this race he not only drove in some of the toughest conditions, but was at the wheel when *Shockwave* hit her highest speed of 24.5 knots while power reaching in a 25 knot+ rain squall.

Shockwave's ocean racing record has been phenomenal. In 2012, the yacht shocked the sailing establishment by winning overall the pro division of the 635 mile Bermuda Race, and then went on to win the 811 mile race to Jamaica known as the Pineapple Cup. The 2012 Bermuda victory was a surprise not only because it was George's first Bermuda Race but because he was up against newer boats skippered and crewed by many time Bermuda Race winners. Other wins include the Astor's Cup and Queen's Cup.

Sakellaris was exposed to sailing in his 20s but he did not begin serious racing until 2010. After racing with chartered yachts in the Mediterranean that did not prove competitive, he purchased the 72-foot *Shockwave*, upgraded the boat and combined a skeleton crew he had put together with some of the past crew of *Shockwave*, finishing a respectable 2nd or 3rd in races in the Caribbean and Mediterranean.

In 2012, he undertook a major upgrade of the yacht to an all-around boat with a new keel and mast and went on to win the NNYC Spring series, and the 2012 Bermuda race on his first try. Mishaps occurred with a return to European racing, but Sakellaris persisted, improving the design of *Shockwave* and winning the 2013 Key West Race Week, following up with the win in the 2013 Jamaica Race, missing the race record by only minutes. With ups and downs continuing in European racing against newer, improved boats, *Shockwave* emerged victorious once again in the Caribbean 600.

However, in the world of yachting, George Sakellaris, with the support and participation of his wife, son and daughter, has established an impressive, perhaps unequaled ocean racing record against some of the best the world has to offer, often at the helm, demonstrating an uncanny talent to focus on the task at hand, giving it his all.

Caras and his wife, Dr. Maria Caras, from Greenville, Delaware, and Patsy Kouvas, a member of the Leadership 100 Board of Trustees, from Warren, Ohio; senior

diplomats from the Greek and Cypriot Embassies and clergy from Greek Orthodox churches in the area.

This exhibit was the first the National Gallery of Art has devoted to Byzantine Art, and the first Byzantine Art exhibit in the US drawn exclusively from Greek collections. The 170 rare and important works, as the National Gallery notes, "offer a fascinating glimpse of the soul and splendor of the mysterious Byzantine Empire...and trace the development of Byzantine visual culture from the fourth to the 15th century, beginning with the ancient pagan world of the late Roman Empire and continuing to the opulent and deeply spiritual world of the new Christian Byzantine Empire." The sculptures, icons, mosaics, frescoes, manuscripts, metalwork, jewelry, glass, embroideries, and ceramics were loaned by the Benaki Museum, and the National Museums of Athens and Thessaloniki.


